INTRODUCTION

Congratulations for taking an interest in a County Elected position. This publication will guide you through the general requirements for each of the County Offices and accessing the ballot either by Assembly, Petition or Write-In. It will also provide you with information regarding the Colorado Secretary of State TRACER system for filing your financial paperwork, as well as, frequently asked questions.

We also encourage you to become familiar with the requirements of Article XXVIII of the Colorado Constitution; Campaign and Political Finance, Title 1, Article 45, C.R.S. Fair Campaign Practices Act; and Title 1, Article 4, C.R.S. Access to Ballot by Candidates.

General Requirements for County Elected Offices and Access to the Ballot

The Delta County Clerk and Recorder has prepared this summary to outline Delta County candidate qualifications and access to the ballot.

This document provides a general overview of candidate qualifications and should be used as a reference guide only.

Always refer to the Colorado Constitution and Colorado Revised Statutes (C.R.S.) for applicable laws.

General Requirements

No person shall be eligible for designation by assembly as a candidate for nomination at any primary election unless the person was affiliated with the political party holding the assembly, as shown on the registration books of the county clerk and recorder, no later than the first business day of the January immediately preceding the primary election, unless otherwise provided by party rules.

County Commissioner

Term of Office

4 years (Term limit- Two 4 year terms)

[Colorado Constitution Article XIV, Section 6; C.R.S. 1-4-205(1)(a)]

Residency Requirement

Registered elector and resident of the district for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10; C.R.S. 1-4-205(1)(b)]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

[C.R.S. 1-4-501(1); C.R.S. 1-2-101(1)(a)]

Number of County Commissioner Seats

[Colorado Constitution Article XIV, Section 6;

C.R.S. 1-4-205(3)(b); C.R.S. 30-10-306(1)]

- Delta County has three (3) seats.
 - One seat is elected at the General Election beginning in 1982 and every 4 years thereafter
 - Two seats are elected at the General Election beginning in 1984 and every 4 years thereafter
- County Commissioner Districts 2 and 3 will be Elected at the 2028 General Election,

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

County Treasurer

Term of Office

4 years

[Colorado Constitution Article XIV, Section 8; C.R.S. 1-4-206; C.R.S. 30-10-701(1)]

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

County Assessor

Term of Office

4 years

[Colorado Constitution Article XIV, Section 8; C.R.S. 1-4-206; C.R.S. 30-10-801(1)]

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the

office as stated in the constitution and statutes on or before the date the term of office begins

County Sheriff

Term of Office

4 years

[Colorado Constitution Article XIV, Section 8; C.R.S. 1-4-206; C.R.S. 30-10-501(1)]

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

[C.R.S. 1-4-501 (1); C.R.S. 1-2-101(1)(a); C.R.S. 30-10-501.5(1)(a)]

Education Requirement

Possess a high school diploma or its equivalent or a college degree

[C.R.S. 30-10-501.5(b)]

Other Requirements

- Complete set of fingerprints taken by a qualified law enforcement agency and submit a receipt evidencing such fingerprinting at the time of filing his or her written acceptance or candidate affidavit [C.R.S. 30-10-501.5(1)(c)]
- A person who has been convicted of or pleaded guilty or entered a plea of nolo contendere to any felony charge under federal or state law is unqualified for the office of sheriff unless pardoned [C.R.S. 30-10-501.5(1)(c)]

County Surveyor

Term of Office

4 years

[Colorado Constitution Article XIV, Section 8; C.R.S. 1-4-206; C.R.S. 30-10-901(1)]

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

Education Requirement

Professional land surveyor

[C.R.S. 30-10-901(1)]

County Coroner

Term of Office

4 years

[Colorado Constitution Article XIV, Section 8; C.R.S. 1-4-206; C.R.S. 30-10-601(1)(b)]

Residency Requirement

Registered elector and resident of the county for at least 1 year prior to the election

[Colorado Constitution Article XIV, Section 10]

Qualification Requirements

U.S. citizen and an eligible elector who is at least 18 years of age and fully meets the qualifications of the office as stated in the constitution and statutes on or before the date the term of office begins

[C.R.S. 1-4-501(1); C.R.S. 1-2-101(1)(a); C.R.S. 30-10-601.5(1)(a)]

Education Requirement

Possess a high school diploma or its equivalent or a college degree

[C.R.S. 30-10-601.5(1)(b)]

Other Requirements

- Complete set of fingerprints taken by a qualified law enforcement agency and submit proof of such fingerprinting when filing a written acceptance [C.R.S. 30-10-601.5(2)(a)]
- A person who has been convicted of or pleaded guilty or entered a plea of nolo contendere to any felony charge under federal or state law is unqualified for the office of coroner unless pardoned. [C.R.S. 30-10-601.5(3)(b)]

Ballot Access

You become a candidate when you publicly announce your intent to run for office and thereafter receive a contribution or make an expenditure in support of your candidacy. You must register a candidate committee with the Secretary of State at tracer.sos.colorado.gov before receiving or spending any money.

All candidates for nominations to be made at any primary election shall be placed on the primary election ballot either by certificate of designation by party assembly or by petition. [C.R.S. 1-4-102]

Certificate of Designation by Party Assembly

- Assembly of major political parties shall be held no later than 73 days preceding the primary election. [C.R.S. 1-4-601(1)]
- A candidate must receive 30% or more of the votes of the assembly to be certified as a candidate for office. [C.R.S. 1-4-601(2)]
- If no candidate receives 30% or more of the votes cast, a second ballot shall be cast on all the candidates for that office by the assembly. If on the 2nd ballot no candidate receives 30% or more of the votes cast, the two (2) candidates receiving the highest number of votes shall be certified as candidates for that office by the assembly. [C.R.S. 1-4-601(2)]
- No person is eligible for designation by assembly as a candidate for nomination at any primary election unless the person has been affiliated with the political party no later than the first business day of the January immediately preceding the primary election, unless otherwise provided by party rules. [C.R.S. 1-4-601(4)(a)]
- Original acceptance must be filed at the County Clerk's Office no later than 4 days after the adjournment of the assembly. If faxed, original must be filed and postmarked no later than 10 days after adjournment. [C.R.S. 1-4-601(3)(a)]
- Certificate of designation by assembly shall be filed at the County Clerk's Office no later than 4 days after the adjournment of the assembly. If faxed, original must be filed and postmarked no later than 10 days after adjournment. [C.R.S. 1-4-604(3)]

Petitions for Major Party Candidates

Petition Requirements

- Name and address of candidate. [C.R.S. 1-4-801(1)]
- Name of office for which the person is a candidate. [C.R.S. 1-4-801(1)]
- Name of the political party that the candidate represents. [C.R.S. 1-4-801(1)]

Format Requirements

- Prior to circulating a candidate petition, the petition format must be approved by the Delta County Clerk and Recorder. [C.R.S. 1-4-903] [C.R.S. 1-4-907]
- The Clerk must approve or disapprove of the petition format by the close of the second business day following the submission of the proposed petition. [C.R.S. 1-4-903]

Signature Requirements

- Must collect the lesser of 1000 signers or signers equal in number to 10% of the votes cast in the political subdivision at the contested or uncontested primary election for the political party's candidate for the office for which the petition is being circulated or, if there was no primary election, at the last preceding general election for which there was a candidate for the office.
[C.R.S. 1-4-801(2)(a)]
- Must be signed by eligible electors within the county commissioner district or political subdivision for which the officer is to be elected. [C.R.S. 1-4-801(2)(a)]
- Signers must be affiliated with the major political party named in the petition for at least twenty-two (22) days prior to signing the petition. [C.R.S. 1-4-904(2)(a)]
- Signers must not have signed any other petition for any other candidate for the same office. [C.R.S. 1-4-904(2)(a)]

SIGNATURES REQUIRED FOR OFFICES FOR 2026 PRIMARY

[C.R.S. 1-4-801(2)(a & (b)]

Commissioner District 1 – Republican – Lesser of 1000 or 10% of votes cast in the 2022 Primary is 590 signatures
Commissioner District 1 – Democratic – Lesser of 1000 or 10% of votes cast in the 2022 Primary is 174 signatures
Clerk and Recorder – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 Primary is 617 signatures
Clerk and Recorder – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Treasurer – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 Primary is 596 signatures
Treasurer – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Assessor – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 Primary is 585 signatures
Assessor – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Sheriff – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 Primary is 621 signatures
Sheriff – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Surveyor – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Surveyor – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures
Coroner – Republican – Lesser of 1000 or 10% of the votes cast in the 2022 Primary is 601 signatures
Coroner – Democratic – Lesser of 1000 or 10% of the votes cast in the 2022 General is 1000 signatures

Additional Information

- No person shall be placed in nomination by petition on behalf of any political party unless the person was affiliated with the political party no later than the first business day of the January immediately preceding the election for which the person desires to be placed in nomination. [C.R.S. 1-4-801(3)]
- No person who attempted and failed to receive at least 10% of the votes for the nomination of a political party assembly for a particular office shall be placed in nomination by petition on behalf of the political party for the same office. [C.R.S. 1-4-801(4)]
- Party petitions shall not be circulated nor any signatures be obtained prior to the first business day in January. [C.R.S. 1-4-801(5)]
- Petitions shall be filed no later the third Tuesday in March. [C.R.S. 1-4-801(5)]
- Candidates by petition for any particular office shall follow assembly candidates and shall be placed on the primary election ballot in an order established by lot. [C.R.S. 1-4-103]
- Petitions for county offices are filed with the County Clerk and Recorder. [C.R.S. 1-4-907]

Petitions for Minor Party or Unaffiliated Candidates

Petition Requirements

- Name and address of candidate. [C.R.S. 1-4-802(1)(a)]
- Name of the minor political party or designate in not more than three words the political or other name selected by the signers to identify an unaffiliated candidate. No name of any political party shall be used, in whole or in part, to identify an unaffiliated candidate. [C.R.S. 1-4-802(1)(a)]

Signature Requirements

- Shall be signed by eligible electors residing within the district or political subdivision in which the officer is to be elected. [C.R.S. 1-4-802(1)(c)]
- Number of required signatures: The lesser of 750 or 2% of the votes cast for all candidates for that office in the most recent general election for any county office. [C.R.S. 1-4-802(1)(c)(VII)]

SIGNATURES NEEDED FOR OFFICES FOR 2026 GENERAL

Commissioner – District 1 – Lesser of 750 or 2% of the votes cast in the 2022 General is 312 signatures

Clerk and Recorder – Lesser of 750 or 2% of the votes cast in the 2022 General is 249 signatures

Treasurer – Lesser of 750 or 2% of the votes cast in the 2022 General is 243 signatures

Assessor – Lesser of 750 or 2% of the votes cast in the 2022 General is 242 signatures

Sheriff – Lesser of 750 or 2% of the votes cast in the 2022 General is 244 signatures

Surveyor – Lesser of 750 or 2% of the votes cast in the 2018 General is 236 signatures

Coroner – Lesser of 750 or 2% of the votes cast in the 2022 General is 246 signatures

Additional Information- Minor Political Party Candidates

- Minor Political Parties may go on the Primary ballot by assembly or petition and the General ballot by petition. [C.R.S. 1-4-1304(1) & (1.5)(a)(b)]
- If only one candidate is designated by the assembly or petition they will be that party's candidate in the general election. [C.R.S. 1-4-1304(1.5)(d)]
- No petition to nominate a minor political party candidate shall be circulated nor any signatures obtained thereon earlier than the first business day in January in the general election year. [C.R.S. 1-4-802 (1)(d)(II)]
- Petitions to nominate candidates of minor political parties shall be filed no later than 85 days before the primary election. [C.R.S. 1-4-802(1)(f)(II)]
- No person shall be placed in nomination by petition unless the person is an eligible elector of the political subdivision or district in which the officer is to be elected and was registered as affiliated with a minor political party or unaffiliated no later than the first business day of the January immediately preceding the general election for which the person desires to be placed in nomination. [C.R.S. 1-4-802(g)(II)]
- Petitions are filed with the County Clerk and Recorder. [C.R.S. 1-4-907]

Additional Information- Unaffiliated Candidates

- No petition to nominate an unaffiliated candidate shall be circulated or any signatures obtained thereon earlier than 173 days before the general election. [C.R.S. 1-4-802(1)(d)(i)]
- Petitions (for unaffiliated candidates) shall be filed no later than 3:00 p.m. on the 117th day before the general election. [C.R.S. 1-4-802(1)(f)(1)]
- No person shall be placed in nomination by petition unless the person is an eligible elector of the political subdivision or district in which the officer is to be elected and was registered as affiliated with a minor political party or unaffiliated no later than the first business day of the January immediately preceding the general election for which the person desires to be placed in nomination. [C.R.S. 1-4-802(g)(II)]
- Petitions are filed with the County Clerk and Recorder. [C.R.S. 1-4-907]

Write-In Candidates

- Affidavit of intent shall be filed stating candidate desires the office and is qualified to assume duties, if elected. [C.R.S. 1-4-1101(1)]
- Affidavit of intent shall be filed with County Clerk and Recorder if it is for a county office. [C.R.S. 1-4-1101(1)]
- Affidavit of intent shall be filed by the close of business on the 67th day before a primary election and by the close of business on the 110th day before any other election. [C.R.S. 1-4-1102(1)]

Important Dates

January 2, 2026

Earliest date to circulate major/minor party petitions for access to Primary Election Ballot. 1-4-801(5)

First Business Day in January

March 18, 2026

Last date to file major/minor party candidate petitions for the Primary Election. 1-4-801-(5)

No later than 3rd Tuesday in March

April 24, 2026

Last day a write-in candidate may file an affidavit of intent for the Primary Election. 1-4-1102(1)

By close of business on the 67th day before the Primary Election

May 14, 2026

Earliest date to circulate unaffiliated candidate petitions for the General Election Ballot 1-4-802(1)(f)(l)

No earlier than 173 days before the General Election

June 30, 2026

Primary Election 1-4-101(1); 1-7-101(1); RULE 7.8.1(b)

July 9, 2026

Last day to file unaffiliated candidate petitions for the General Election 1-4-802(1)(f)(l)

No later than 3:00pm on the 117th day before the General Election

July 16, 2026

Last day for a write-in candidate to file an Affidavit of Intent for the General Election. 1-4-1102(1)

November 3, 2026

General Election 1-1-104(17); 1-4-2015; RULE 7.9.1(b)
