Check list for removing a manufactured home from a permanent location and disposing at the Delta County Landfill:

Prior to demolition of a manufactured home, Colorado State Law requires:

- ☐ **An inspection by a state-certified inspector for presence of asbestos. The owner must then submit a Notice of Demolition Form to the Colorado Department of Public Health and Environment. Information on these requirements may be obtained here:**

IMPORTANT:

IT IS THE RESPONSIBILITY OF THE OWNER OF THE MANUFACTURED HOME TO ASSURE THAT NO HAZARDOUS MATERIALS OR TOXIC WASTES (e.g., asbestos, freon refrigerant, etc.) ARE CONTAINED IN THE STRUCTURE WHEN A MANUFACTURED HOME IS PRESENTED FOR DISPOSAL AT THE DELTA COUNTY ADOBE BUTTES LANDFILL. MANUFACTURED HOMES WILL ONLY BE ACCEPTED FOR DISPOSAL AT THE LANDFILL WHEN THEY HAVE BEEN INSPECTED AND CERTIFIED AS FREE OF ASBESTOS OR ANY OTHER MATERIALS DEEMED UNACCEPTABLE FOR DISPOSAL AT THE LANDFILL. WHEN THE MANUFACTURED HOME IS ACCEPTED FOR DISPOSAL/SALVAGE BY A PRIVATE DISPOSAL OR SALVAGE COMPANY, THE PERSON OR COMPANY ACCEPTING THE HOME IS ALSO RESPONSIBLE FOR ASSURING THAT THE MANUFACTURED HOME TO BE DESTROYED IS FREE OF HAZARDOUS MATERIALS OR TOXIC WASTES (e.g., asbestos, freon refrigerant, etc.). ALL HAZARDOUS MATERIALS MUST BE DISPOSED OF LEGALLY WHEN THE MANUFACTURED HOME IS DESTROYED.

NOTE: For information about disposal of manufactured homes at the Delta County Landfill and for additional information on asbestos inspections, please contact the Delta County Assessor's office.

You must submit to the Delta County Health Department for their signature and approval:

- ☐ **Approved Notice of Demolition form from the Colorado Department of Public Health and Environment, along with a copy of the asbestos inspection report**
- ☐ **Manufactured Home Destruction and Disposal Affidavit (MHDDA).**
This form must be signed prior to disposal at the Delta County landfill (form attached).

You must obtain from the County Treasurer:

- ☐ **Tax Authentication/Moving Permit.** You must obtain this from the County Treasurer. The County Treasurer will charge a \$10 fee for the authentication and moving permit. All outstanding taxes and current year taxes on the manufactured home must also be paid at this time.
- ☐ **Manufactured Home Destruction and Disposal Affidavit (MHDDA).**
This form must be signed prior to disposal at the Delta County landfill.

You must submit for recording to the recording section of the County Clerk’s office (recording fees will be charged):

- ☐ **Tax Authentication**
- ☐ **Certificate of Destruction** (Writable form*)
- ☐ **Certificate of Removal.** This form must be completed, signed, and notarized. (Writable form*)
- ☐ **Proof of recorded Affidavit of Real Property (*affixed prior to July 1, 2008*).** If this document has not been previously recorded, it must be completed, signed, notarized, and recorded. (Writable form*)
- OR -
Proof of recorded Certificate of Permanent Location (*affixed after July 1, 2008*). If this document has not been previously recorded, it must be completed, signed, notarized, and recorded. (Writable form*)
- ☐ **Manufactured Home Destruction and Disposal Affidavit (MHDDA)**

*Writable forms may be filled in online and printed. The filled in portions will not be saved after printing. Writable forms can be found at Colorado Department of Property Taxation. Select the option “Forms” and the appropriate form needed.
